

Privacy Policy for Cube Smash

Privacy Policy Last updated: July 30, 2023

This Privacy Policy describes our policies and procedures for collecting, using, and disclosing your information when you use the Service and informs you about your privacy rights and how the law protects you. By using the Service, you agree to the collection and use of information in accordance with this Privacy Policy.

Interpretation and Definitions

Interpretation Words with capitalized initials have defined meanings under the following conditions. The following definitions have the same meaning regardless of whether they appear in singular or plural form.

Definitions For the purposes of this Privacy Policy:

- Account means a unique account created for you to access our Service or parts of our Service.
- Affiliate means an entity that controls, is controlled by, or is under common control with a party, where "control" means ownership of 50% or more of the shares, equity interests, or other securities entitled to vote for the election of directors or other executive authorities.
- Application refers to Cube Smash, the software program provided by the Company.
- Company (referred to as "the Company," "We," "Us," or "Our" in this Agreement) refers to Cube Smash.
- Country refers to: Italy.
- Device means any device that can access the Service, such as a computer, mobile phone, or digital tablet.
- Personal Data refers to any information relating to an identified or identifiable individual.
- Service refers to the Application.
- Service Provider means any natural or legal person who processes data on behalf of the Company. It refers to third-party companies or individuals employed by the Company to facilitate the Service, provide the Service on behalf of the Company, perform services related to the Service, or assist the Company in analyzing how the Service is used.
- Usage Data refers to data collected automatically, generated by the use of the Service or the Service infrastructure (e.g., the duration of a page visit).
- User means the individual accessing or using the Service or the company, or another legal entity on behalf of which such individual is accessing or using the Service, as applicable.

Personal Data

Types of Data Collected

Personal Data During your use of our service, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you. Personally identifiable information may include, but is not limited to:

- Usage data

Usage data

Usage Data is collected automatically when you use the Service.

Usage Data may include information such as your device's Internet protocol address (for example, IP address), browser type, browser version, pages of our Service that you visit, time and date of your visit, the time spent on those pages, unique device identifiers and other diagnostic data.

When you access the Service on or through a mobile device, we may collect certain information automatically, including but not limited to the type of mobile device you use, your mobile device's

unique ID, your device's IP address mobile phone, operating system, the type of mobile Internet browser used, unique device identifiers and other diagnostic data.

We may also collect information that your browser sends whenever you visit our Service or when you access the Service from or through a mobile device.

Use of your personal data

The Company may use Personal Data for the following purposes:

- To provide and maintain our Service, including monitoring usage of our Service.
- To manage your account: to manage your registration as a user of the service. The Personal Data you provide may give you access to various features of the Service that are available to you as a registered user.
- For performance of a contract: the development, compliance and performance of the purchase agreement for the products, items or services you have purchased or any other agreement with Us through the Service.
- To contact you: to contact you by email, telephone call, SMS or other equivalent forms of electronic communication, such as push notifications from a mobile application relating to updates or informational communications relating to the contracted features, products or services, including updates of security, when necessary or reasonable for their implementation.
- To provide you with news, special offers and general information about other goods, services and events we offer that are similar to those you have already purchased or inquired about, unless you have opted out of receiving such information.
- To manage your inquiries: To participate in and manage your inquiries to Us.
- For business transfers: We may use your information to evaluate or conduct a merger, assignment, restructuring, reorganization, dissolution or other sale or transfer of some or all of our assets, whether as a going concern or as part of a bankruptcy , liquidation , or similar proceeding, where Personal Data held by us about users of our Service is among the transferred assets.
- For other purposes: We may use your information for other purposes, such as data analysis, identifying usage trends, determining the effectiveness of our promotional campaigns, and to evaluate and improve our service, products, services, marketing and your experience.

We may share your personal information in the following situations:

- With service providers: We may share your personal information with service providers to monitor and analyze usage of our service, to contact you.
- For corporate transfers: We may share or transfer your personal information in connection with, or in the negotiations of, any merger, sale of Company assets, financing or acquisition of all or a portion of our business to another company.
- With affiliates: We may share your information with our affiliates, in which case we will require those affiliates to honor this Privacy Policy. Affiliates include our parent company and any other subsidiaries, joint venture partners or other companies that we control or are under common control with us.
- With business partners: We may share your information with our business partners to offer you certain products, services or promotions.
- With Other Users: When you share personal information or otherwise interact in public areas with other users, that information may be viewed by all users and may be publicly distributed externally.
- With your consent: We may disclose your personal information for any other purpose with your consent.

Retention of your personal data

The Company will only keep your personal data for as long as necessary for the purposes set out in this Privacy Policy. We will retain and use your personal data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies.

The Company will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period of time, except when this data is used to strengthen the security or to improve the functionality of Our Service, or when We are legally required to retain this data for longer periods of time.

Transfer of your personal data

Your information, including Personal Data, is processed at the Company's operating offices and in any other place where the parties involved in the processing are located. It means that this information may be transferred to - and held on - computers located outside your state, province, country or other governmental jurisdiction where data protection laws may differ from those in your jurisdiction.

Your consent to this Privacy Policy followed by your submission of such information represents your consent to that transfer.

The Company will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy and no transfer of your personal data will take place to an organization or a country unless they are in put in place adequate controls, including the security of your data and other personal information.

Delete your personal data

You have the right to delete or request our assistance in deleting the personal data we have collected about you.

Our Service may give you the ability to delete certain information about yourself from within the Service.

You can update, change or delete your information at any time by logging into your account, if you have one, and visiting the account settings section which allows you to manage your personal information. You may also contact us to request access, correction or deletion of any personal information you have provided to us.

Please note, however, that we may need to keep certain information when we have a legal obligation or legal basis to do so.

Disclosure of your personal data

Business transaction

If the Company is involved in a merger, acquisition or asset sale, your personal data may be transferred. We will provide notice before your personal data is transferred and becomes subject to a different Privacy Policy.

Law enforcement

Under certain circumstances, the Company may be required to disclose your personal data if required to do so by law or in response to valid requests by public authorities (such as a court or government agency).

Other Legal Requirements

The Company may disclose your Personal Data in the good faith belief that such action is necessary to:

- Comply with a legal obligation
- Protect and defend the rights or property of the Company
- Prevent or investigate possible wrongdoing in connection with the Service
- To protect the personal safety of Service Users or the public
- Protection against legal liability

Security of your personal data

The security of your personal information is important to us, but please remember that no method of transmission over the Internet or method of electronic storage is 100% secure. While we strive to use commercially acceptable means to protect your personal information, we cannot guarantee its absolute security.

Children's privacy

Our service is not directed to anyone under the age of 13. We do not knowingly collect personally identifiable information from anyone under the age of 13. If we become aware that we have collected personal data from persons under the age of 13 without verification of parental consent, we take steps to remove that information from our servers.
